## Dear Jeff Mateer,

We're writing to you as parents to another parent. We love our children, and you must love your own. We love them fiercely, and sometimes we fear for them. We want to tell you about our families, and how we love and fear for our children, because President Trump has nominated you for a lifetime appointment as a U.S. district court judge. Mr. Mateer, that makes us afraid for our children, because our children are transgender.

As parents, we are deeply disturbed by your remarks stating that children like ours are evidence of "how Satan's plan is working." It is hard to imagine a crueler thing to say about a child. It is obvious from your remarks in 2015 that you did not know the child whose very existence you mocked. Have you ever met a transgender child like ours? If you met our families, you would know that while children like ours can face a lot of misunderstanding, there is nothing wrong with who they are.

We believe our children are miracles, like every child—not a part of "Satan's plan." As every reputable medical and pediatric association agrees, there is nothing wrong with being transgender, and children like ours can grow and thrive if they are loved and supported, just like their peers. According to the American Academy of Pediatrics, "transgender children fare much better when they feel supported by their family, school and larger community. Shaming children based on their gender identity or expression is harmful to their social-emotional health and may have lifelong consequences."

We know this to be true because we have seen it with our own eyes. We have loved and supported our children through our own initial uncertainties about what it means to be transgender, through months or years of exploring their gender identity, through countless conversations with experts and other parents, through the fear—and for some of us the reality—of bullying from our children's peers or even from adults, and through the relief and the joy of seeing our children be able to live their truth, be seen for who they are, and just be kids. We can't help but wonder if you have ever taken a moment to put yourself in our shoes, or in the shoes of our children. As parents we are alarmed that you, as a state official and a nominee for a lifetime position of immense responsibility, would engage in rhetoric that not only publicly shames but demonizes our children and so many others like them.

We are also alarmed by your past statements appearing to endorse damaging "reparative" or "conversion" therapy practices that have been rejected by the medical community and can cause terrible harm to children like ours. To quote the American Academy of Pediatrics and the American College of Osteopathic Pediatricians:

"Although a handful of unethical clinicians still employ reparative [or conversion] therapy, the medical and mental health professions have discredited and condemned it. Major professional organizations, including the American College of Physicians, the American Academy of Pediatrics, the American Psychoanalytic Association, the American School Counselor Association, the American Psychological Association and the National Association of School Psychologists have explicitly rejected efforts to change a child or adult's gender identity or gender expression."

In short, the reason why numerous states and cities have banned conversion therapy is that it is a fraud that endangers children like ours. As parents, we cannot imagine that someone who promotes such practices could be fit to hold an office with such broad and grave responsibilities as a federal judge—or that children or families like ours could count on a fair hearing from such a judge in a case of any kind.

Hundreds of thousands of children and adolescents throughout this country are transgender, like our kids. Like all children—like your children, Mr. Mateer—they deserve to grow up knowing that they are loved and supported. Your statements about children like ours are the opposite of love—they are cruel. We urge you to apologize sincerely and without reservation to us and our families and all the others like us, and to clearly articulate how wrong and damaging your words are to children like ours—or to withdraw your nomination.
